- 2. Experienced outdoor advertising companies / business firms with good reputation and sound financial background will be eligible. They will be entitled to participate in the open auction through their authorized agents.
- 3. Following are the main terms and Conditions:-
 - Period of Agreement 3 Years + (1 Year extendable).
 - <u>Terms & Conditions</u>:-
 - 1 x Month's rent as security and 1x Month's rent in advance (*non-negotiable*).
 - 8% Annual increase in rent.
 - Each participating company should be registered with Registrar Firms. Following supporting documents will be provided along with letter of interest to participate:-
 - Letter of authorization in favor of person participating in the open auction.
 - All the participating Companies / Firms shall submit an undertaking to abide by the concerned advertisement rules and code of Ethics approved by APNS.

- Proof of FBR certificate.
- Bidders will also be required to deposit Bank statement of the company / firm for the last six months and company's / firm's profile.
- Any Vendor/ Company working with DHA, failing to submit the outstanding dues will not be permitted to participate in auction.
- Companies failing to provide the above mentioned document will not be allowed to participate in thebidding.
- Letter of Interest including information about authorized agent who will participate on the behalf
 of company along with Pay order of Rs. 500,000/- (refundable) should be submitted with DHA
 office before of the auction day. Cheque and CDR will not be accepted. Security amount will
 be confiscated if bid winner will withdraw his auction.
- The participating company will provide an undertaking that it has never been black listed by any authority / Boards. In case a wrong certificate is provided, then complete security will be confiscated in favor of DHA Lahore and agreement will be cancelled.
- DHA may postpone the bidding time / date without assigning any reason.
- DHA reserves the right to accept or reject any or all bids without assigning anyreason.
- The decision of the Authority will be final.
- The DHA will display skin on licensed billboard for a minimum 5 x days on National Days/ Nationwide Campaigns (23rd March, 14th Aug, 6th Sep, 9th Nov, 25th Dec and Eids, etc;), as and when required, with no monetary or time compensatory obligations on DHA.
- On Digital Media, DHA will own 1 x slot of minimum during complete agreement period on FOC basis. DHA can use this slot for Public Service Massages and for DHA own Promotion.
- Stability Certificate will be the responsibility of Vendor.
- Any other aspects deemed appropriate by the management.
