### DOCUMENTS REQUIRED

1. Application form duly filled by the Owner / Attorney
2. Original and 1 x photocopy of paid challan of Water & Sewerage Connection charges
3. Photocopy of CNIC of the Owner / Attorney
4. 2 x identical colored photographs of front elevation of house / building on photo paper (6" x 4" Size) showing complete elevation including beam area / driveway and paved area etc. In case of corner plot, 2 x additional photograph (6" x 4" Size) of side elevation are also required.
5. 1 x Photocopy of Site Plan with current Owner's name
6. In case of 10KW or above Solar System is installed, attach a copy of bill from some renowned Solar System provider company on their letter head showing the purchase and installation date of the system. (For houses measuring 1 Kanal & Above) – **if applicable**, You are requested to incorporate provision of following documents for utilization of incentive for deployed solar system at their respective project at the time of processing new application of water and sewerage connection:-
  - a. Copy of LESCO green meter permission letter or electricity bill of property.
  - b. Solar company AEDB license valid copy (Solar Company)
  - c. Stability certificate of load bearing of your roof top from your structure engineer (Structure Engineer of Owner Property).
  - d. Solar Panels mounting/elevated structure stability certificate against wind velocity (Solar Company).
  - e. Commissioning certificate of solar system electric / earthing / mechanical seamless integration is also mandatory (Property Owner).
  - f. Note: Please follow DHA by laws for installation of solar system.
7. In case of **commercial building**, undertaking for post construction maintenance / water sewerage connection, on stamp paper of worth Rs. 100/- duly attested by Oath Commissioner.

#### Note:

- After site visit by the field staff of building control branch and if satisfied with the construction as per approved drawing, having no construction violations, recommendation for opening of both the connections is made.
- Water & Sewerage Connection will be provided after flooring, plastering, gate, doors, windows, electrification, and plumbing of the house / building are ready.
- If the house/ building found occupied prior to the opening of water/ sewerage connections then member will be liable to pay fine as per prevailing rates.
