- 5. Undertaking by the seller and purchaser. (In relation to Govt taxes)
- 6. Photocopies of the valid Computerized National Identity Card (CNIC) of both Seller and Buyer duly attested by Oath Commissioner.
- 7. 2 x latest Passport size photographs(with blue background) duly attested by class one officer.
- 8. RegistrationFee of new Owner.
- 9. Registration Form (Available at Finance Counter).
- 10. Cantt Board Taxes.
- 11. Original Transfer Letters/ Sales Deed along with affidavits of Seller and Purchaser are required to be surrendered in case of registered plot.
