faculties and senses and of my free will and without any coercion or duress, do hereby solemnly affirm and
declare as under:-

- a. I'm owner of House No. _____ Sector _____ Phase _____
Measuring _____, situated in Defence Housing Authority, Lahore Cantt.
- b. Open Plot No. _____ Sector _____ Phase _____ Measuring
_____ situated in Defence Housing Authority, Lahore Cantt, is owned by Mr./ Mrs./
Ms. _____ whose relation with me is _____.
- c. I will not make any permanent structure like porch, swimming pool construction of generator
room, guard room etc or any other structure approved by engineer incharge. Only soft
landscaping like rockeries, waterfall, water bodies, plat forms and removable canopy/parasol
can be done.
- d. I will not construct the boundary wall beyond the specified height of 7' from the road level and
will **not** provide independent **gate** therein on front boundary wall of lawn.
- e. I will use the plot only for lawn purpose and pay full water charges for area of plot _____
(Marla / Kanal) in addition to my house no. _____.
- f. I will not arrange / undertake any activity which causes nuisance to adjacent residents by any
means. In case of violation or complaint by neighbours, DHA management can impose fine /
cancel the lawn usage permission and disconnection of services (water/ sewer connection) after
fact finding through site investigation.
- g. I will use water from existing water connection and there is no need for fresh connection for the
said plot.
- h. I will maintain prescribed open spaces of two plots.
- i. I will not plant high rise trees along with common boundary walls.
- j. **I will pay water charges of lawn from the date of physical demarcation of plot which will
be used as lawn with adjacent House No. _____.**
- k. **I will collect / pay monthly water bill at DHA counter / online transfer through Bank and
deposit the slip with Coord Branch Maintenance of the water charges paid for lawn Plot
No. _____ I undertake to pay any arrears charges for water bill of House
No. _____.**
- l. In case any construction in the plot or specified open spaces is made, DHA Management may
impose construction penalty of **Rs. 500,000/-**, or disconnect services of House No _____
without notice in addition to cancellation of membership or both of above.
- m. I will pay non construction penalty, which is applicable for open plot as per rules.
- n. In case of breakup of relationship (God forbid) undertaking will become invalid & the original
status of open plot will be maintained forthwith. If any dispute arises between us, DHA is neither
responsible nor party to any civil proceeding.

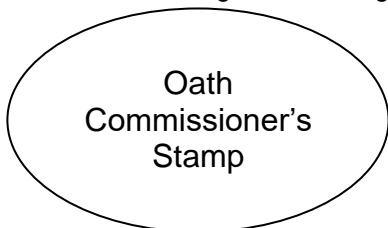
